1. Program Description

Master Program in Security and Communal Peace Studies, is a trans-disciplinary study program, at the level of postgraduate studies dedicated to advance knowledge, research, and practices, on security and peace studies. Through a time duration lasting 4 semesters, the program offers different courses and study themes related to security, peace, and reconciliation; strategy, security policy, security theories, and rule of law. The interrelation between security and communal peace.

2. Overall objects of the program

To advance knowledge and research on security studies in relation with communal peace.

To contribute to communal peace and rule of law in Palestine as a matters of higher national priority.

To advocate good security practices in Palestinian security sector including peaceful approaches.

3. Specific Objectives of the program

- To provide students with an in depth knowledge and research in security subjects and to relate them with communal peace.
- To enable students to have practical experience related to security and communal peace.
- To advance scientific research on security studies. - To contribute to reconciliation studies from security perspective.

4. The Rationale of the program

Palestinian community is widely known as a divided society due to political division in the Palestinian political system between main rival Palestinian streams, Fatah and Hamas. As well, Palestinian communities suffer lack of



security and order; Palestinian security forces and police that established by Oslo Agreement of 1994 between PLO and Israel, enjoy limited rule over Palestinian Territories which remained under the Israeli overall control. Despite ongoing training and professionalizing of the Palestinian security, their rule is seriously hindered by Israeli security dominance from one hand and by internal Palestinian community tensions from another. Upon this background, achieving communal peace and rule of law has become a priority in the Palestinian case. As Al-Isiqlal University is a salient educational institution dedicated to security education in Palestine, communal peace has become one of its main concerns within the security studies domain. Master program in security and communal peace is regarded as an important contribution on this regard; It is expected to provide security sector and other practitioners in the field with qualified staff on the strategic level which are expected to affect Palestinian security policy making that regards communal peace as part of the security policy and practices. As well, the program is expected to engage civil society organisations involved in security sector and justice with qualified staff that may contribute to justice and rule of law.

Finally, the program is expected to advance research on peace and reconciliation studies in relationship with security performance.

5. Scientific Discipline

The program is defined as part of security and peace studies albeit it concentrates on internal peace making at the level of society rather than international security. However, the program adopts transdisciplinary approach since it cuts across different scientific disciplines to create a coherent learning model on security and communal peace; fields such as law, sociology, political science and security studies.

6. Study Plan

The program is consisted of (36) credited hours which are composed of (27) compulsory CH, including thesis and 9 optional CH). That is additional to pre-requested courses offered from the graduate level for students admitted from out of the discipline. Courses are disputed as follows:

6.1 Preliminary courses: are usually targets applicants out of the discipline, so as to fill in gap knowledge and / or to systemize basic principles of the program. Applicants identified are expected to obtain one or more of the



following courses offered by the relevant faculty from the BA level, as a pre-request;

Course Title	Essential Readings in Security
Pre-Requested	None
Course Description	The course formulates a conceptual background on security studies including; meaning of security, whose security, levels and pillars of security. In addition, the course provides basic concepts related to security, including strategy, security theories and their reflections

	in international politics, security policy, and security sector.
Outputs	Students are expected to apprehend a full comprehension of security related themes depending on essential readings. Particularly, students are expected to address the concept of security in terms of notion, levels, and applications at the level of the state and community; to highlight the concept of strategy, war, and peace, theories of international relations and their security implications; to address the concept of security policy and security sector. - Students are expected to have practicing on security related applications and modeling.

Course title	Civil Conflicts, Reasons, and Reflections
Pre-requested	
Course description	The course addresses civil – conflicts in terms of their historic development, sources, motivations, and their structural relationship with society and political structure. It shows the possible reflections of ethnic, societal, and tribal divisions on motivating communal tensions on different levels.



Outputs	<ul style="list-style-type: none"> - Students are expected to have knowledge on civil conflicts within different social/ communal contexts; to apprehend relationship between the fabric of society, its socio- economic and political structure and between the liability of producing social tensions and divisions. - Students are expected to perfume different applications on civil conflicts, to build models and to contextualize communal tensions in the Palestinian arena.

Course title	Reconciliation Studies and Conflict transformation

Course description	<p>The course introduces reconciliation as a trans disciplinary approach in social sciences; it highlights the concept of reconciliation and its different aspects. In addition, the course addresses reconciliation as a social and political process and its impact on conflict transformation. Finally, it analyzes reconciliation upon different social and political, internal and external contexts, showing its different applications on the sphere of conflict transformation.</p>
Outputs	<ul style="list-style-type: none"> - Students are expected to apprehend the meaning of reconciliation; to fully understand its trans disciplinary character, and to grasp its different applications in relation to peace building and stability either in the level of internal and external politics. - Students are expected to relate reconciliation to conflict transformation and peace building, as well as to internal security in a divided society.

Course description	The course introduces for the concept of communal peace; particularly, it's function in the context of transitional communities and in fragile societies, where rule of law is generally weak. In addition, the course shows possible connection between communal peace and law enforcement by showing the role of Para-judiciary formations in achieving justice in such fragile societies.

The importance of security sector reform in formulating a shared national vision over security; It discusses the different aspects of security governance including legal reforms, and re-building security organizational structures, and the role of civil society in achieving civilian control over security forces. Finally, it connects security sector reform on maintaining communal peace.

	<p>occupation hinders rule of law in Palestinian occupied territories; It discusses the role of social structures, committees in achieving communal peace such as reconciliation committees and community traditional leaders.</p>

Teaching Methods

Teaching Master in Security and Communal Peace Studies is based on a combination of different teaching methods as follows:

1. Interactive lectures: lectures are delivered according to an interactive manner; asking questions, solving problems, student presentations, and focus groups discussions.
2. Practical learning: in the scope of providing students with skills needed for their security profession, and to increase understanding of the themes offered by the program, teaching of the masters in security and communal peace, depends on practical cases and examples from actual experience. This may include building training models or analyzing cases related to security, rule of law, or communal reconciliation.
3. Co-teaching: practitioners from security sector, politicians, parliaments, as well as specialized academics are welcomed to engage in teaching and training in the program.
4. Mixture between face to face and remote learning; so as to enable partners from out to engage in the program, teaching uses electronic platforms including electronic classes and on-line classes. Electronic platforms are used to enhance learning tactics and to provide learning sources as well.

Student Evaluation and Grading

Teaching of the program follows regulations adopted by Al-Istiqlal
